Dear Praying Friends:

You see here most of the 47 children in the Blue Bird Christian Orphanage in Pusan, Korea. Mrs. Kim, seen in the center, has been pleading for help for many months. It has been highly recommended, but we have not been able to send any money for we had no sponsors. We did send the picture rolls and Mrs. Kim wrote on October 20th: "When I explained with the wonderful pictures to them who have been learning the Bible story by only speaking, you will never know how much our children enjoyed it. How can we express our thanks to you? We have no adequate words. God will know our thanks."

In another letter just received, Mrs. Kim says: "My heart is far anxious and my responsibility is getting more heavy I can feel. I sincerely respect and esteem you, dear Rev. Swanson. Please look after my painful heart. I desire you would look after these simple and innocent children in our Orphanage. Five head of pig are dead and even ducks are weak. The children grow to be much big, try to take much meals, and clothes are much needed. So my heart becomes very anxious. If we get nothing support from you, the way of our living in future is far dizzy. I earnestly hope you would be kind enough to think of our children who cry with cold and hunger."

What shall I do? What would **you** do? We have decided to send her \$50 for December (small as it is) and have asked her to prepare the children's pictures and case histories and to airmail them to us. Then we will pray and tell you of this need hoping to get many new sponsors for these dear orphaned children.

### Six Months TRIAL Plan Now Offered

In our last letter to you we asked you to pray with us for 500 new sponsors by Christmas. We asked you to help by showing the pictures to friends, relatives and church groups.
